

Pay and Working Conditions in Social Care (WICARE): Project Information

EPSU is involved in new project investigating pay and conditions in the social services sector: WICARE.

This is a major survey of workers in social care across 34 countries. The WICARE project will use online questionnaires set up on the international network of [Wage Indicator](#) websites. These will be available in national languages along with paper versions of the survey.

The project runs until November 2014 and EPSU is working with researchers at [AIAS](#) (Amsterdam, The Netherlands) and [CELSI](#) (Bratislava, Slovakia).

The project, WICARE, will be similar to the **earlier project [WISUTIL](#)** which focused on pay and conditions in energy, waste and water.

EPSU affiliates will be asked to **encourage their members in social care to complete the survey** - either online or on paper.
