#### PRIVATIZATION

• PRIVATIZATION IS THE PROCESS OF TRANSFERRING THE OWNERSHIP OF AN ENTERPRISE, FIRM, AGENCY, PUBLIC SERVICE OR REAL ESTATE FROM THE PUBLIC SECTOR TO THE PRIVATE SECTOR OR TO PRIVATE NON-PROFIT ORGANIZATIONS;

- THE CONCESSION IS THE RIGHT TO EXPLOIT AN OBJECT OF PUBLIC INTEREST GRANTED BY A CONCESSIONAIRE TO A TRADER-CONCESSIONAIRE, AGAINST THE OBLIGATION TO BUILD OR MANAGE AND MAINTAIN THE CONCESSION OBJECT AT ITS OWN RISK.
- IT IS BASED OF A LONG-TERM WRITTEN CONTRACT WITH A CERTAIN MATERIAL INTEREST CONCLUDED BETWEEN THE GRANTOR AND THE CONCESSIONAIRE;
- ACCORDING TO ITS OBJECT MAY BE: CONCESSION FOR CONSTRUCTION, SERVICES AND EXTRACTION;
- •THE TERM OF THE CONCESSION IS UP TO 35 YEARS WITHOUT THE RIGHT TO CONTINUE;

- SOFIYSKA VODA AD WAS ESTABLISHED IN OCTOBER 2000 BY A 25-YEAR CONCESSION AGREEMENT. UNDER IT THE MUNICIPALITY OF SOFIA GRANTS TO THE COMPANY THE OPERATION AND MAINTENANCE OF SOFIA'S WSS SYSTEM.
- SOFIYSKA VODA IS A JOINT STOCK COMPANY WITH 77.1% OF THE SHARES PARTICIPATING IN ONE OF THE LEADING FRENCH COMPANIES FOR PUBLIC UTILITIES VEOLIA. THE REMAINING 22.9% OF THE SHARES ARE IN SOFIA MUNICIPALITY.
- SOFIYSKA VODA IS NOT THE OWNER, BUT RATHER THE CONCESSIONAIRE OF THE WSS ASSETS WHICH ARE PUBLIC STATE PROPERTY. ALL NEW FACILITIES CONSTRUCTED WITH THE COMPANY'S FUNDS ARE ALSO THE PROPERTY OF THE CITY.

#### **HOW DID THE UNION REACTED?**

- IN 2000 WE SIGNED MEMORANDUM FOR PARTNERSHIP WITH INTERNATIONAL WATER, BASED ON THE CONCESSION CONTRACT AS A GUARANTEE FOR THE RESPONSE OF SOCIAL DIALOGUE AND KEEPING THE EXISTING COLLECTIVE AGREEMENT; IN 2004 INTERNATIONAL WATER SELL TO UNITED UTILITIES AND IN 2008 UNITED UTILITIES TO VEOLIA;
- FOFIYSKA VODA AD HAS 1170 EMPLOYEES;
- F CIW PODKREPA HAS TRADE UNION ORGANIZATION WITH 130 TRADE UNION MEMBERS; CITUB HAS ALSO TRADE UNION ORGANIZATION WITH 300 TRADE UNION MEMBERS;
- THE COMPANY AND THE UNIONS HAS SIGNED THE LAST COLLECTIVE AGREEMENT FOR TWO YEARS SINCE 04.07.2017;

#### BEST PRACTICES IN THE COLLECTIVE AGREEMENT

- - ANNUAL INDEXATION OF THE SALARIES WITH THE % OF INFLATION FOR THE LAST YEAR;
- - 22 DAYS ANNUAL PAID HOLIDAYS WITH 1 DAY MORE FOR EACH THREE YEARS INTERNSHIP IN THE COMPANY;
- 7 LV. DAILY VOUCHER FOR FOOD;
- MONTHLY CARD FOR TRANSPORT;
- PAID MOTHERHOOD FOR THE SECOND YEAR MORE THAN THE STATE - GUARANTEED MATERNITY (370LV. MONTHLY) 760 LV. THAT IS THE MINIMAL WAGE FOR THE BRANCH (IN 2017 THERE WERE 25 MOTHERS)
