Defending and strengthening trade union rights in public services

The conference is organised jointly with the European federations for police and military personnel, EuroCOP and EUROMIL. We may initially limit participation to one participant per affiliate in order to ensure participation from as many countries as possible. We would encourage affiliates to nominate women representatives to help ensure a good gender balance.

Please register as early as possible to ensure a room in the hotel, the provision of interpretation and to help us plan the running of the conference and, in particular, the working groups.

TIMING AND VENUE

The conference will run from 9.00 to 17.00 on Thursday 22 September and will take place at the Holiday Inn, Filip Vtori Makedonski 5, Skopje, 1000.

TRAVEL AND ACCOMMODATION

European Commission funding means that participants from all EU Member States plus the candidate countries of Albania, Montenegro, North Macedonia, Serbia and Turkey can claim reimbursement for travel and accommodation costs up to certain limits.

Additional funding from EPSU will also be available to help affiliates from Eastern Europe outside the EU who wish to participate.

Reimbursement for travel will be to a maximum of **€350** per participant. In order to be reimbursed, tickets/receipts must be kept and sent back to EPSU after the conference with the expense claim. Travel by public transport and private cars can be covered but journeys by taxis/ride-hailing apps will not be reimbursed.
