# Press invitation – April 7

## European day of action against Health commercialization

April 7 is the World Health Day. Its the day choosen by Health users and workers, citizen collectives, trade unions, NGOs and international networks to demonstrate against Health commodification.

Actions and demonstrations are planned in several European cities: Madrid, Barcelona, Zarogosa, Paris, Lille or Brussels.

A Call was launched to the population to support the action hanging a white sheet at the windows to defend a Health away from commercialization drifts. Hashtags #Health4All #SantePourTous #GezondheidVoorIedereen #SaludParaTodos will be used on social medias.

### In Brussels, different activities are planned:

- **Press conference at 10:00** at CSC-ACV-BIE, rue de Trèves 31, 1040 Brussels

Perspectives of the different initiators\*: mechanisms of commercialization in Europe; impact of this commercialization on Health workers; a reality going beyond Health sector and the possible resistances to this commercialization.

A conference on Health commercialization in Europe at 11:00 will follow the press conference in the same place

With testimonies of the impact of commercialization in the different European countries: Greece, Spain, Ireland, Nederlands or France and Belgium. But also beyond: Turkey.

The presentation of a website on Health commercialization in Europe.

Proposals to strengthen convergences against Health commercialization.

### A visual action at Schuman at 14:00\*\*

(between Schuman rond-point and Cinquantenaire park entrance)

Installation of two hospitals: one for rich people, the other for poors. We will hang white sheets in front of EU institutions to send a message against commercialization and for the right to Health for all.
