Overview of Webinar 2: TPV and Gender-based violence

- GBVH was chosen as a webinar topic it is an increasingly important risk. Three presentations:
 - GBV and ILO Convention 190: Manuela Tomei (ILO)
 - European Commission's forthcoming legal framework on GBV: Karen Vandekerckhove (European Commission)
 - Domestic violence at a workplace issue: Jane Pillinger (TPV Project expert/researcher)
- GBVH is included in ILO C.190 and R.206 (including gender-responsive risk assessments etc.)
- Importance of mitigating the risks of domestic violence in the context of the workplace
- Important legal developments:
 - European Commission's forthcoming draft Directive on GBV
 - Ratification of ILO C190 across EU Member States
- Discussions about guidelines and GBV. Key issues raised about:
 - the need for policy coherence
 - greater risks faced by women in front-line services e.g. health and social care
 - importance of building trust in complaints systems
 - awareness raising / guidance on addressing and prevention GBV, including domestic violence and digital abuse
 - examples of successful initiative



Preliminary online survey findings

(as of 22.10.2021, responses from 162 organisations: 48% unions, 62% employers)

- 62% say TPV is an extremely serious or very serious problem
- 42% say it has negatively impacted on the quality of the service provided
- 44% say COVID-19 has had a big impact
- Types of TPV: verbal aggression, followed by psychological harassment and threats, physical assault and sexual harassment


Seriousness of TPV



- Similar results across countries
- Sectors where TPV is reported most frequently as serious or very serious: prisons, hospitals & urban public transport
- TPV has become more serious with COVID-19
- Evidence from recent surveys of a worsening situation post-lockdowns

Policy measure to assess risks, prevent and manage TPV

Examples of policy measures (all sectors)



- TPV is a significant and growing risk
- 55% said it was included in OSH policies, and in risk assessment & prevention plans
- 40% reported having complaints mechanisms / monitoring of complaints
- 33% had a policy to prevent and manage TPV
